# *S6*

We have been linking with the S6 to support study spaces. We have held two assemblies and identified the spaces that are available and shared a timetable with the S6 to ensure that they are aware. We have also shared this information with all staff to ensure a consistency of approach and support. The S6 have study spaces in the following places:

We had a follow up assembly with the S6 today to ensure that this was working and had improved the experience for the S6.

#### Digital

All young people across S1 – S6 now have an iPad to support their learning. We were involved in the CEC Thematic Review in the summer term, focused on empowered learning. This had positive feedback with the key points of:

When given the opportunity, pupils used digital technology confidently. Teams and One Note is
used consistently across the school. In almost all lessons observed, digital learning is used
effectively to enable pupils to access their learning. Practice should be developed to ensure
technology used enhances learning.

We are reviewing the school mobile phone policy, and this will be one of the short life working groups that we would like parents and carers to be involved with.

We have implemented the mobile policy with all year groups. The S1 has been continued from their three-day visit. With all others putting phones away during class time. This has been shared and reinforced with staff.

#### SLWG

We are establishing three short life working groups.

These will include parents / carers, pupils and staff. The aim would be for these groups to meet frequently over a short period of time to review and develop the policies and have them updated and in place over the course of this academic year.
